**OFFICE MEMORANDUM**

**Subject: Cancellation of offer of appointment for the post of Assistant Communication Officer (ACO) post code No. NW11720 in DCPW, MHA.**

The undersigned is directed to refer this Directorate's OM of Even No. dated 13.06.2023 and 22.07.2023 vide which offer of appointment for the post of Assistant Communication Officer (ACO) in DCPW, MHA, were issued.
