2. The terms and conditions of appointment is as under:-

- (i) They will be placed below all the existing Assistant Communication Officers (Cipher).
- (ii) Their promotion if any will be made to any grade only after completion of prescribed years of service in the grade of Assistant Communication Officers (Cipher) from the date of 'Absorption' and as per the provisions of the Recruitment Rules for the post where promotion is to be made.
- (iii) They can be posted anywhere in India. Their cases of transfer will be dealt as per the 'Transfer Policy' of this Directorate.
- (iv) Their pay in the grade will be regulated as per the existing rules of the Govt. of India.
- (v) Their seniority will be fixed interalia with other Assistant Communication Officers (Cipher) already on deputation, if absorbed later on in their respective grades as per prevalent rules.
- (vi) They are required to be given Cipher Training in PUCC-II and PUCC-I courses conducted by DCPW.
